# IMPORTANT, PLEASE READ THIS FIRST. THIS IS A LICENSE AGREEMENT.

THIS LEGAL AGREEMENT IS BETWEEN YOU (EITHER AN INDIVIDUAL OR AN ENTITY) AND INNOVYZE. BY INSTALLING AND USING THE ENCLOSED SOFTWARE, YOU ARE ACCEPTING AND AGREEING TO BE BOUND BY ALL OF THE FOLLOWING TERMS AND RESTRICTIONS OF THIS AGREEMENT.

IF YOU DO NOT AGREE WITH THESE TERMS AND RESTRICTIONS, PROMPTLY RETURN THE UNUSED SOFTWARE, ACCOMPANYING WRITTEN MATERIALS AND PACKAGING WITH DATED PROOF OF PURCHASE TO THE PLACE WHERE YOU OBTAINED THEM WITHIN THIRTY (30) DAYS FROM PURCHASE AND YOU WILL RECEIVE A FULL REFUND.

# 1. Grant of License

Innovyze grants you a nonexclusive, non-transferable license to use this program (the "Software") and its manual and other accompanying material ("Documentation") with equipment owned by you or under your control, according to the terms and conditions of this Agreement.

- 1.1 Single Site Version: Unless otherwise specified, this software is a single license. The product may be used on personal computers or workstations within the site. Your provided standalone USB key will authorize the program to run.
- 1.2 Local Area Network Version (LAN): If this Software is a local area network version, you may use it only over an internal [loc al] area network environment with the Innovyze local area network lock. You may only install and operate the Software on a single server computer in a single office location with the maximum number of concurrent users being the number of user licenses owned and programmed into the USB key within the same office location. The number of concurrent users within the single office location can only be increased by purchasing additional concurrent user licenses.
- 1.3 Wide Area Network Version (WAN): If this Software is a wide area network version, you may use it with the provided Innovyze wide area network lock at any location within national boundaries. It is a requirement that you establish protocols to ensure that only users within the same country as the wide area network license can use this application. The number of concurrent users within each country can only be increased by purchasing additional licenses. A minimum of two WAN licenses must be purchase d to qualify for this license.
- 1.4 Educational Version: If this Software is an educational version, you may use it only for the purpose of training and instruction, and for no other commercial, professional, or for-profit purposes. The product may be used for twelve (12) months (except where obtained under a lease or rental agreement refer to 1.8).
- 1.5 Demonstration/Evaluation Version: If this Software is identified as a demonstration or evaluation version, you may use it only for the purpose of evaluation and demonstration for the authorized trial period. You may not use it for commercial, professional, or for-profit purposes.

### 2. Restrictions

- 2.2 reverse engineer, decompile, or disassemble the Software.
- distribute, rent, loan, lease, sell, sublicense, or otherwise transfer all or part of the Software, Documentation or any rights granted hereunder to any other person or entity including non-registered offices of the Licensee.
- 2.4 install or use the Software on the Internet or over a wide area network, including, without limitation, use in connection with a Web hosting or similar service.
- 2.5 remove, alter, or obscure any proprietary notices, labels, or marks from the Software or Documentation.
- 2.6 modify, translate, adapt, arrange, or create derivative works based on the Software or Documentation for any purpose.
- 2.7 utilize any equipment, device, software, or other means designed to circumvent or remove any form of copy protection used in connection with the Software, or use the Software together with any hardware lock, authorization code, serial number, or other copy protection device not supplied by Innovyze directly or through an authorized distributor.
